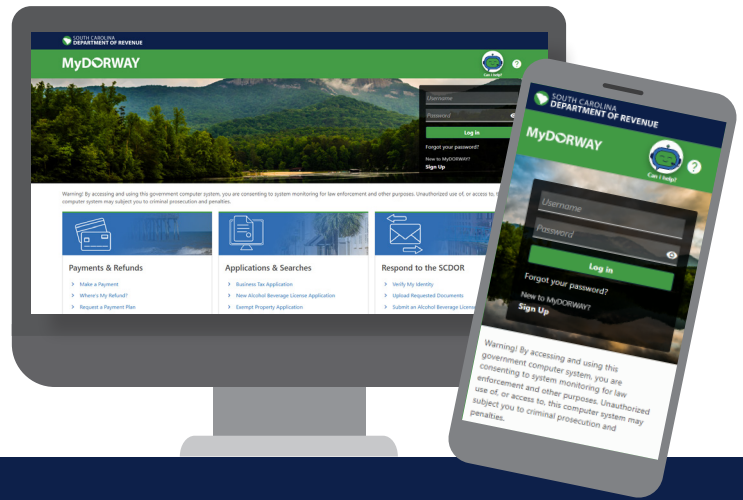


# Tare Allowance Refund Application and Instructions

## APPLY FOR YOUR MOTOR FUEL REFUND ON MyDORWAY!

- Apply for refunds using your Fuel Vendor account. Contact the SCDOR at [MotorFuelTax@dor.sc.gov](mailto:MotorFuelTax@dor.sc.gov) if you do not have a Fuel Vendor license.
- Ensure that you have a recent Letter ID to use in the registration process. Contact the SCDOR to request an updated Letter ID.
- Confirm the **Type of Ownership** listed on your registration with the IRS.
- Attach a completed L-2118 or **verified spreadsheets for each fuel type** to your MyDORWAY Tare Allowance Refund Application.

## Tare Allowance Refund Application | L-2117

Apply for a refund online at [MyDORWAY.dor.sc.gov](https://MyDORWAY.dor.sc.gov)

Taxpayers can apply online for a Motor Fuel Refund account. Once the account is created, taxpayers can apply for a refund of Motor Fuel Taxes using [MyDORWAY.dor.sc.gov](https://MyDORWAY.dor.sc.gov), our free online tax portal. Create a MyDORWAY account or log in to get started.

This document provides general information about **L-2117, Tare Allowance Refund Application**.

### WHO MAY APPLY FOR A REFUND

- Fuel Vendors who have eligible purchaser status.

### REGISTERING TO APPLY FOR MOTOR FUEL REFUNDS ON MyDORWAY

- If you've never submitted a license application for a Fuel Vendor account, complete and submit the L-2045, Application for a Motor Fuel License, available at [dor.sc.gov/tax/motor-fuel/forms](https://dor.sc.gov/tax/motor-fuel/forms).
- After you receive your Motor Fuel License, visit [dor.sc.gov/MyDORWAY-signup](https://dor.sc.gov/MyDORWAY-signup) to create your MyDORWAY account.
- You can add existing tax accounts to your MyDORWAY account by logging in and selecting the **More** tab, then choosing **Request Account Access**.

### WHAT YOU WILL NEED TO APPLY FOR A REFUND

- Your Motor Fuel Vendor Account Number
- Your Federal Employer ID Number (FEIN)
- **For Tare Allowance refunds** – Attach the L-2118, Eligible Purchaser Schedule of Motor Fuel Purchases. A separate L-2118 form should be submitted for each fuel type. The L-2118 is available at [dor.sc.gov/tax/motor-fuel/forms](https://dor.sc.gov/tax/motor-fuel/forms).
- In some cases, a spreadsheet can be submitted that includes the required information.
  - Contact the SCDOR at [MotorFuelTax@dor.sc.gov](mailto:MotorFuelTax@dor.sc.gov) to verify that your spreadsheet contains the correct information before you submit a spreadsheet instead of copies of invoices or receipts.

### HOW TO APPLY FOR A MOTOR FUEL REFUND ON MyDORWAY

- Log in to your MyDORWAY account and select the **Accounts** tab, then scroll to your Motor Fuel Vendor Tax Account and click **More Account Options**.
- On the next screen, select **Tare Allowance Refund Application (L-2117)** to get started.
- You are required to attach a completed L-2118 for each fuel type or attach verified spreadsheets for each fuel type to the MyDORWAY refund application.

### WHEN TO APPLY

Tare Allowance Refunds must be applied for quarterly.

## REFUND OPTIONS

If you apply for a refund on MyDORWAY, you have the option to select a direct deposit or paper check refund.

You have the option to request a paper copy of the L-2117 by emailing [MotorFuelTax@dor.sc.gov](mailto:MotorFuelTax@dor.sc.gov). If you submit a paper application, a paper check is your only refund option. Allow 8 weeks for processing.

## SPECIAL INSTRUCTIONS

- If you need to create a Motor Fuel Refund account by submitting a paper copy instead of using MyDORWAY, email [MotorFuelTax@dor.sc.gov](mailto:MotorFuelTax@dor.sc.gov) to request a copy of the Motor Fuel Registration Form (L-2140).
- There is no provision in the law for an extension on a claim for refund. Your refund claim must be submitted within three years of the fuel purchase date.
