



Fuel Blender Monthly Return | L-2115

File online at MyDORWAY.dor.sc.gov

Taxpayers are required to file and pay Motor Fuel Returns electronically. File and pay on MyDORWAY.dor.sc.gov, our secure online tax portal. Create a MyDORWAY account or login to get started. If you do not file and pay electronically, a penalty of \$5,000 per filing period will apply. This electronic mandate went into effect March 1, 2019.

This document provides general information about the Fuel Blender Monthly Return and required schedules.

WHO NEEDS TO FILE

- Fuel Blenders

WHEN TO FILE

- **Due date:** The Fuel Blender Monthly Return and payment are due by the last day of the month following each filing period. (For example, your January return is due by the last day of February.)
- You must file a Fuel Blender Monthly Return even if you have no tax liability for the month.

WHAT YOU WILL NEED WHEN YOU FILE

You will need the following information for the filing period:

- Your Motor Fuel License Number and Federal Employer ID Number (FEIN)
- Completed [Schedule A - Product Blended \(L-2196\)](#) and [Schedule B - Gallons Purchased \(L-2197\)](#). You will be required to attach these schedules when you submit your return. Schedules are available at dor.sc.gov/forms.

SPECIAL INSTRUCTIONS

- Complete a separate Schedule A based on the blend percentage and type of product. The blend percentage shows the percentage of the product blended into the fee paid product.

EXAMPLE: E01 - E99

- Where EXX refers to the percentage of fuel grade ethanol blended with gasoline. For example: E10 is 90% gasoline blended with 10% fuel grade ethanol. The blend percentage cannot be E00, B00 or D00. These product codes represent 100% of the fuel grade and not blend percentages.

- \$0.0025 Inspection Fee
- \$0.005 Environmental Impact Fee
- Motor Fuel User Fees and effective dates

Prior to July 1, 2017	\$0.16
July 1, 2017 - June 30, 2018	\$0.18
July 1, 2018 - June 30, 2019	\$0.20
July 1, 2019 - June 30, 2020	\$0.22
July 1, 2020 - June 30, 2021	\$0.24
July 1, 2021 - June 30, 2022	\$0.26
July 1, 2022	\$0.28
