Instructions

Keep the Worksheet portion of this form for your records. Record purchases subject to Use Tax. When entering the four digit county or municipality code on your Use Tax payment return, use the four digit code listed on the last page of the instructions. If the items purchased are for storage, use, or other consumption in a municipality, use the municipality code.

Use Tax is due on purchases of tangible goods if South Carolina Sales Tax was not paid. Examples include: catalog purchases, goods bought online, or furniture purchased out of state and delivered in South Carolina on which no or insufficient South Carolina tax was paid. (Contrary to popular misconception, the federal Internet Tax Freedom Act governs taxation of access to the internet through your internet-access provider. Goods purchased online are not tax free.) When calculating your Use Tax, review your credit card statements and any large purchases made during the taxable year.

Credit: You can subtract tax paid to another state or local jurisdiction from your Use Tax due. For example, if you purchased furniture in another state and paid that state's Sales Tax, you would subtract the tax you paid from your Use Tax calculation.

You have three options for reporting and paying Use Tax:

- 1. On your Individual Income Tax Return. No additional form or paperwork is required.
- 2. Online using our free tax portal, MyDORWAY, at MyDORWAY.dor.sc.gov. Sign into your existing account or create an account to get started. No additional form or paperwork is required.
- 3. Mail the UT-3 with check or money order payable to "SCDOR" to: SCDOR, Sales Taxable, PO Box 100193, Columbia, SC 29202.

Sales and Use Tax Rates by County

Use the Sales Tax rate of the county where you are located or other applicable rate wherever tangible personal property was delivered. Some counties impose a local Sales and Use Tax in addition to the state's 6% rate. The chart below lists the combined tax rate for counties with additional local Sales and Use Taxes. Assessment Time Limitations for Use Taxes

Code Section 12-54-85(C) allows the assessment of the state Use Tax, or a local Use Tax administered and collected by the SCDOR on behalf of a local jurisdiction, beyond the standard 36 month limitation when it is "the result of information received from, or as a result of exchange agreements with, other state or local taxing authorities, regional or national tax administration organizations, or the federal government. The Use Taxes in this case may be assessed at any time within 12 months after the SCDOR receives the information, but no later than 72 months after the last day the Use Tax may be paid without penalty."

Social Security Privacy Act Disclosure
It is mandatory that you provide your Social Security Number on this tax form if you are an individual taxpayer. 42 U.S.C. 405(c)(2)(C)(i) permits a state to use an individual's Social Security Number as means of identification in administration of any tax. SC Regulation 117-201 mandates that any person required to make a return to the SCDOR must provide identifying numbers, as prescribed, for securing proper identification. Your Social Security Number is used for identification purposes.

The Family Privacy Protection Act
Under the Family Privacy Protection Act, the collection of personal information from citizens by the SCDOR is limited to the information necessary for the SCDOR to fulfill its statutory duties. In most instances, once this information is collected by the SCDOR, it is protected by law from public disclosure. In those situations where public disclosure is not prohibited, the Family Privacy Protection Act prevents such information from being used by third parties for commercial solicitation purposes.
