

How to pay with MyDORWAY

Visit dor.sc.gov/pay

- Select Individual Income Tax Payment
- Enter SSN, ITIN, or FEIN and Legal Name, and select Individual Income Tax
- Next, select Return Payment
- Enter the required information, and select a payment method
- Next, complete the required steps for the selected payment method
- **Do not mail a paper copy of the SC1040V if you pay online**

The fastest, easiest way to pay what you owe is by using our free online tax portal, MyDORWAY, at dor.sc.gov/pay. Select **Individual Income Tax Payment** to get started. Do not mail a paper copy of the SC1040-V if you pay online.

- If you owe \$15,000 or more in connection with any SCDOR return, you must file and pay electronically according to SC Code Section 12-54-250.
- If you're making a quarterly Declaration of Estimated Tax payment, use the SC1040ES.
- If you file by paper, use only black ink on the SC1040-V form and on your check.
- Enter your Social Security Number (SSN) and your spouse's SSN (if filing jointly).
- Check the **Composite Filer** box if this payment will be claimed on a SC1040, Individual Income Tax Return, filed for nonresident partners or shareholders of a Partnership or S Corporation.
- Enter your name and address, including apartment number and ZIP code.
- Enter your payment amount in whole dollars without a dollar sign (example: 154.00).
- Your payment amount should match the balance due on line 34 of your SC1040.
- You can file your return electronically by the due date and pay your balance due electronically by May 1, 2026, without being charged penalties and interest. If you don't meet both requirements, the SCDOR will charge penalties and interest from the tax due date (April 15, 2026) until you file and pay.
- If you filed your SC1040 electronically with a balance due, **do not** include a paper copy of your return when you mail your SC1040-V.
- If you file your SC1040 by paper and have a balance due, submit your payment with the return. **Do not** mail your payment separately with the SC1040-V.
- Make your check payable to SCDOR. Include your name, SSN, and 2025 SC1040-V in the memo. **Do not send cash.**
- Mail your SC1040-V and payment in one envelope.

Social Security Privacy Act Disclosure

It is mandatory that you provide your Social Security Number on this tax form if you are an individual taxpayer. 42 U.S.C. 405(c)(2)(C)(i) permits a state to use an individual's Social Security Number as means of identification in administration of any tax. SC Regulation 117-201 mandates that any person required to make a return to the SCDOR must provide identifying numbers, as prescribed, for securing proper identification. Your Social Security Number is used for identification purposes.
