




>> Step 3. Select the "Sign in or create an account" action button.




>> Step 4. Choose one of the secure **Sign In** options. Enter User name and passwords according to sign in choice.




>>Step 5. Select the "Get Your VA Benefit Letters" action button.




- >> Step 6. Review your address.
