This form provides a list of Sales Tax rates on accommodations for South Carolina counties and municipalities. The SCDOR administers and collects these taxes on the behalf of the counties and jurisdictions.

An individual 85 years old or older is entitled to claim a 1% exemption from state Sales and Use Tax on purchases for their own personal use. They must provide proof of age at the time of the sale. For more information, see SC Revenue Ruling #16-9, available at dor.sc.gov/policy.

Local tax name abbreviations are: **LO** - Local Option, **CP** - Capital Projects, **SD** - School District, **TT** - Transportation Tax, **ECI** - Education Capital Improvement, **TD** - Tourism Development, **NL** - No Local Sales/Use Tax Imposed

Counties must meet certain criteria for imposing a Local Tourism Development Sales & Use Tax. As of the effective date of this chart, the City of Myrtle Beach, located in Horry County, is the only municipality located in a qualifying county that has chosen to impose the tax.

The tax rate information on this chart lists the current tax rate at the time of the effective date. This chart is revised periodically to reflect changes in each jurisdiction's Sales Tax rate. Counties can impose a new tax rate at any time, which would impact the tax rates shown. A complete updated list of all counties with local taxes can be found at dor.sc.gov/tax/sales.

This chart only addresses the general state and local option taxes collected by the SCDOR on behalf of the counties, municipalities, and school districts. It does not address the local taxes on sales of accommodations that are collected directly by the counties or municipalities.
