## These important local tax changes go into effect May 1, 2019:

County/Code	Local Tax Change	Total State and Local Rate Effective May 1, 2019
Georgetown County 1022	1% Capital Project Tax - ending due to revenue collections	6% General Tax Rate 7% Accommodations Tax Rate
Beaufort County 1007	1% Transportation Tax - per the November 2018 referendum	7% General Tax Rate 8% Accommodations Tax Rate
Calhoun County 1009	1% Capital Project Tax - per the November 2018 referendum	8% General Tax Rate 9% Accommodations Tax Rate
Saluda County 1041	1% Capital Project Tax - per the November 2018 referendum	8% General Tax Rate 9% Accommodations Tax Rate

- Georgetown County's 1% Capital Project Tax ends after April 30, 2019.
- Beaufort County's new 1% Transportation Tax starts May 1, 2019.
  - Purchases made with food stamps will be exempt from the new 1% Transportation Tax.
  - Report this tax under code 1007 on page 3 of the ST-389.
- Calhoun County's new 1% Capital Project Tax starts May 1, 2019.
  - This is in addition to Calhoun County's 1% Local Option Tax.
  - All sales of unprepared food (not only purchases made with food stamps) will be exempt from the new 1% Capital Project Tax.
  - Report this tax under code 1009 on page 1 of the ST-389.
- Saluda County's new 1% Capital Project Tax starts May 1, 2019.
  - This is in addition to Saluda County's Local Option Tax.
  - All sales of unprepared food (not only purchases made with food stamps) will be exempt from the new 1% Capital Project Tax.
  - Report this tax under code 1041 on page 1 of the ST-389.

### Other Sales Tax news - new municipal code:

- The town of Van Wyck has been incorporated in Lancaster County.
- Van Wyck's municipal code is 2925.
- Use this municipal code on the ST-389 (page 4) to report sales and on the ST-3T to report accommodations within the municipal limits of Van Wyck.
