- Warehouse hours are Monday through Friday, 8:30 AM to 4:00 PM.
- The SCDOR will not issue your refund until SCDOR warehouse personnel verify the amount and value of the paper being returned and the Bingo Licensing and Enforcement Division processes your request.
- If there are discrepancies in the amount and value of the returned paper and what is reported on the FS-92 or FS-92C, the SCDOR's count will be final.
- Any paper returns that do not follow these instructions will be refused.
